- 2. All expressions shall be prepared and submitted in accordance with the requirements outlined here-in. Failure to comply with any requirement shall cause the proposal to be considered unresponsive and may be grounds for rejection.
- 3. By accepting to participate in this request for solicitation, you agree NOT to share the request with any other party thus enabling them to participate. The Company reserves the rights to invite prospective bidders.

The Solution Provider will be responsible for providing the software solution to LLK and to assist in implementation and support maintenance. The fully fledged Integrated Policy Administration Management System is expected to cover the following, amongst other key functions: –

- Financial Management
- Electronic documents management
- Biometric membership data management capability

- Hardware, software & OS and data base management requirements


The minimum criteria for pre-qualification (short-listing) of the consulting firms shall include, but not limited to the following:

- Vendor must demonstrate the relevant experience, competencies, skills, and qualifications for the supply and implementation and support of the required system.
- The vendor should have successfully implemented a similar system in at least three insurance companies preferably in long term business.
- Demonstration of financial soundness (submit certified 3-year audited financials).
- The firm must be compliant with the relevant tax laws (refer to section 7 below).
